Abstract

The collection of drawings documents a wide range of federal and state trials between 1970 and 1990 and other subjects up to 2004 by Richard Tomlinson. Tomlinson was a NYC based courtroom artist whose drawings appeared mainly on TV news (NYC Channel 5) and also in newspapers.

Biographical note:

Richard Allan Tomlinson was born in Akron, Ohio in 1933. He studied at the Art Center School in Los Angeles 1954-1956 and the School of Visual Arts, NYC 1968-1969. As an artist Richard Tomlinson dedicated 20 years of his life to courtroom drawings. He was the courtroom artist for Channel 5 News. The media used by Tomlinson was marker, charcoal, graphite, pastel, crayon, and gouache paint. His client list included Metromedia Television News, Fox Television News and CNBC Business News. He was featured in Art in America, and New York Newsday, Illustrators in America and The Society of Illustrators. His entire collection of courtroom art has been acquired by the John Jay College of Criminal Justice. Tomlinson was employed for a long time as a media artist by WNEW TV, channel 5, Metromedia Television in New York. Richard Tomlinson died in 2010.

Tomlinson's extensive trial credits include the Black Panther 13, David 'Son of Sam' Berkowitz, and the trials of Robert Chambers, *Abscam*, Jack Henry Abbott, Rev. Sun Myung Moon, Jean Harris, Bernhard Goetz, John Gotti, and the Bonanno Mafia family. He also covered the cases of Ariel Sharon v. Time Magazine, and General Westmoreland vs. CBS.

His work has been featured in several exhibitions including a 1976 exhibition at Syracuse University for which the catalog: *Contemporary Courtroom Artists* (Syracuse: Lowe Art Gallery), and a 2017-18 exhibit at John Jay College, Shiva Gallery, *Rogues Gallery: 1977 – 2017 – 40-year retrospective of courtroom art: From Son of Sam to el Chapo* and the book *The Illustrated Courtroom: 50 years of Court Art (*2014),. Furthermore, his work has been exhibited at The Museum of Television and Radio, The Society of Illustrators, The Art Directors Club, the American Institute of Graphic Arts, and at Rutgers University Law Library, Camden. Richard Tomlinson was a guest in an episode on Courtroom Artists of the television show, *Criminal Justice Close-Up*, produced by CUNY-TV/John Jay College in 1987 (MP4 file of this episode is available upon request).

Series Description:

Richard Tomlinson's courtroom drawings is comprised of oversized folders, portfolios, framed drawings, VHS tapes and 35mm negatives.

- 1. **SERIES I 18 Oversized Folders**: Contains identified and unidentified drawings in black and white and color, primarily related to courtroom trials and general subjects not related to trials.
- 2. **SERIES II 72 Portfolios**: Contains identified and unidentified drawings in black and white and color, primarily related to courtroom trials and general subjects not related to trials. Some portfolios contain drawings categorized by trial or year.
- 3. **SERIES III 37 Framed Drawings**: The framed items depict various significant events and individuals in the legal and criminal justice system from 1970 to 1990. They include scenes such as high-profile trials, competency hearings, arraignments, witness testimonies, and verdicts involving notable figures like David Berkowitz, Mark David Chapman, Jean Harris, John Gotti, and Leona Helmsley.
- 4. **SERIES IV Box 1**: Contains videos of drawings by Tomlinson, primarily for FOX TV news, covering various trials and news stories.
- 5. **SERIES V Box 2:** Contains slides and negatives sheets of drawings by Tomlinson, including courtroom scenes and artist renderings of subjects not related to trials.

Scope and Content:

The collection is arranged in 5 series. Series I-III are original drawings of a wide range of case trials and hearings grouped by size and format. Portfolio (S. II) are left in the original order as received. Many drawings in the folders (S. II) and frames (S. III) were taken out of these portfolios during exhibits preparations. Drawings of the same case or trial might be spread across several folders or portfolios, please review the whole container list for all drawings of particular trials. VHS tapes (S. IV) are listed below. The 35mm slides (S. V) have not been sorted or arranged.

The collection overview consists primarily of oversized folders and portfolios containing drawings categorized by specific trials, legal proceedings, or subjects, providing a comprehensive collection of courtroom art and related materials. VHS videos of drawings and 35mm negatives sheets in color and black and white are also included in the collection. Overall, the collection provides a comprehensive visual record of various trials, news events, and courtroom scenes, offering insights into the legal and social landscape of the depicted time period. Some drawings are not necessarily related to any trials and may include portraits, and other unrelated imagery.

The historical or cultural significance of the collection lies in its documentation of various trials, legal proceedings, and significant events throughout the late 20th century. The collection provides a visual record of landmark events such as the ABSCAM Trial, The Black Panther Trial, Bernhard Goetz Trial, the Howard Beach Trial, the Baby M. Trial, the Alice Crimmins Trial in 1971, David Berkowitz trial in 1977, Mark David Chapman in 1980, the John Gotti Trial in 1986, the Bess Myerson trial in 1988, and Robert Chambers trial in 1988. Additionally, there are random drawings of tropical scenes. These drawings offer unique insights into the legal process, the individuals involved, and the broader societal context in which these trials took place. Additionally, the collection reflects the evolution of courtroom artistry and its role in journalism and storytelling.
