Historical Background of Collection:

This collection is mainly comprised of the papers of Anthony Magiaracina also known as 'Tony Grapes". The materials were collected by Magiaracina during his career as a drug enforcement agent and enforcer with several Federal narcotics control agencies; he was stationed in Rome in 1959, NYC in 1961 and was with the BDAC in 1966 and the BNDD after 1968. The papers focus particularly on Italian Mafia crime organizations and figures active in drug trafficking in



the United States and abroad with materials dating as early as 1934 and as late as 1979, but most dating to the 1960s.

The papers document the work of Magiaracina and others working on narcotics investigation and enforcement in several federal agencies, including: FBN (The Federal Bureau of Narcotics, U.S. Department of the Treasury), 1966-1968 BDAC (Bureau of Drug Abuse Control, Food and Drug Administration) after 1968 BNDD (The Bureau of Narcotics and Dangerous Drugs, U.S. Department of Justice) and after 1973, DEA (Drug Enforcement Administration, U.S. Department of Justice). All of these and other acronyms appear in the collection, but the bulk of the documents appear to date to activities of the BDAC, FBN and BNDD in the 1960s.

Scope and Content Notes:

The papers of this collection document the specialized narcotic investigations of Magiaracina during his time in several agencies. The papers reflect the extensive work and knowledge needed to investigate crime families and enforce safety from crime and narcotics. The papers include various administrative records such as case reports, memos that describe witness fees and trials, trial transcripts, receipts and invoices, and maps and biographies of persons of interest.

Additionally, the papers include personal records from Magiaracina such as correspondence, licenses to carry firearm, and diaries. Some of the collection, including a Metropolitan Dade

County Public Safety Department Bulletin and charts used to organize the hierarchy in crime families have been digitized.

This finding aid has been updated to reflect the most recent contents of the collection. While the original acquisition consisted of 5 boxes, 3 boxes were added to the collection in 2017 and 2 were added in 2021. Because the collection was donated in parts between 2012 and 2021, the series listings will reflect the acquisition of the records by year. Since the first acquisition was received by two sources, the first two series are arranged to reflect that. The third series reflects the second acquisition that took place in 2017, and the fourth, which also includes files from Douglas Valentine, reflects the acquisition that took place on 2021. It is likely the entire collection was once together and originally belonged to Magiaracina.
