BURTON TURKUS PAPERS Finding Aid

The Burton Turkus Papers in the Lloyd Sealy Library Special Collections Room document the professional life of Burton Turkus (1902-1982). The bulk of our portion of his papers focus on his work as Assistant District Attorney and Chief of the Homicide Division in the Office of the District Attorney, Kings County (Brooklyn) 1940-1945. During this time he investigated and prosecuted key members of the organized crime syndicate based in Brownsville, Brooklyn that came to be known as "Murder Inc."
