## **Commissioner Patrick V. Murphy Papers**

#### **Biographical Note:**

Patrick V. Murphy started his career as a patrol officer in New York City in 1945 and by 1963 was appointed as Chief of Police in Syracuse, NY to reform the police department in the wake of a corruption scandal. His reputation as a reformer was further established in the subsequent leadership roles he assumed: Deputy Chief Inspector of NYPD (1964-65); Assistant Director of the U.S. Justice Department's Office of Law Enforcement Assistance (1965-67); Public Safety Director of Washington, DC (a position created for him) (1967-68); and Police Commissioner of Detroit Police Department (1969-70). Mayor John V. Lindsay appointed him as Commissioner of the New York Police Department in 1970 to reform the police department at the time of the Knapp Commission, a period of notorious corruption and scandal. (See: The Knapp Commission Records, Special Collections, John Jay College for transcript of Murphy's testimony) He established guidelines of police restraint in shooting suspects which became a model around the nation. He created an internal review board to evaluate shots fired by police officers off the target range and sharply increased the accountability of higher ranking police officers. Murphy continued in his tenure there for three years until becoming president of the Police Foundation, a non-profit institution created to foster improvement and innovation in policing. Under his thirteen year leadership (1973-1985), police practices and policies underwent significant changes. He emphasized the use of police restraint and a reduction of the use of arms in dealing with public disorder. There was a move away from the use of highly visible patrol cars to an increase in community policing. Women were encouraged to become patrol officers and African-American officers were promoted to higher positions.

From 1985 to 1998 Murphy was Director of the Police Policy Board of the US Conference of Mayors. He advocated the creation of local police networks to increase the level of effectiveness and quality of policing in fighting crime. Murphy formed a number of consulting practices, some solely and others as a partner, between the years 1985 and 1996. He was an assistant to the Independent Commission on the Los Angles Police Department (Christopher Commission) which investigated the Rodney King incident (1991); and was hired as a consultant by Prince George's County (Maryland) (2002-04) to reform the Prince George's County Police Department and address the issue of excessive police force and allegations of police abuse.

Patrick V. Murphy is one of the interviewees of *Justice in New York: An Oral History Project* of John Jay College, Lloyd Sealy Library, a collection of taped interviews of leaders in criminal justice and law enforcement in New York. His interview will be available in our Special Collections.

# **Scope and Content Note**

The records mostly reflect Murphy's years as a private consultant to various agencies. There is very little from his years as police commissioner in New York or the other cities where he held similar positions. Murphy's writings, speeches and statements (Series 4) and the drafts of writings, letters and notes (Series 2) are the most representative of his life-long interest in improving the quality of police service, community policing, the reform of police practices, police accountability, the reduction of the use of arms in policing and fostering better police and minority relations.

#### **Series Descriptions**

#### Series 1. Biographical Material, 1970-2002 Box 1

Arranged chronologically. Contains Murphy's resumes, autobiographical material, references, and articles about Murphy as found in *Current Biography Yearbook, New York Times, Washington Post* and other publications.

#### Series 2. Notes and drafts of letters, writings, and statements,1991-2004 Box 2

Arranged chronologically. Consists chiefly of handwritten drafts of letters to various colleagues and officials, including President George W. Bush, Mayor David Dinkins, Mayor Rudolph Giuliani, and Jack Johnson (Prince George's County Executive). Also includes notes on staff meetings, drafts of writings, memoranda and statements.

#### Series 3. Correspondence, 1975-2004 Box 3

Arranged chronologically. Consists chiefly of incoming correspondence. Some noteworthy correspondence includes letters to NY Mayor David Dinkins, Assistant U.S. Attorney General Wesley Pomeroy, NYPD Commissioner Raymond Kelly, NYPD Deputy Commissioner James Fyfe, and incoming correspondence from Theodore Cardinal McCarrick, Archbishop of Washington, D.C., and Thomas Repetto (Citizens Crime Commission of NY).

#### Series 4. Writings, speeches, statements, 1971-2004 Box 4

Arranged chronologically. Contains book chapters, articles, drafts of articles, speeches, presentations, statements and notes written by Murphy. Includes both photocopies of publications and handwritten notes.

#### Series 5. Business Files Boxes 5-8

## Series 5a Murphy, Mayo & Associates, Inc., 1987-2000 Boxes 5-6

Loosely arranged chronologically. Includes administrative records such as brochures, a press release and a contract for services of a consulting firm which Murphy established with Louis Mayo in 1987. Also contains correspondence, reports and financial records associated with this company.

# Series 5b American Police Association, 1996-2003

#### Box 7

Arranged chronologically. Includes administrative records such as the certificate of registration for the American Police Association, a non-profit organization which Murphy and Mayo established as a forum for college-educated police officers in 1996. Contains correspondence, including a 2001 letter from Murphy to President Clinton. Also includes press releases, bank statements and tax forms, and APA Newsletters and drafts of newsletters.

# Series 5c U.S. Conference of Mayors, 1998

#### Box 7

Contains correspondence and drafts of letters Murphy wrote during the period he was an advisor to the U.S. Conference of Mayors on policing issues in major urban areas.

# Series 5d Prince George's County Police Department, Office of Police Reform, 2002-2004

#### Box 8

Arranged chronologically. Comprised of correspondence, memoranda, press releases, preliminary reports and drafts of reports, financial records, telephone staff directories, and a computer diskette of records in relation to Murphy's work as consultant for Prince George's County (Maryland).

# PATRICK V. MURPHY: Chronology

Born May 15, 1920

(Brooklyn, Bay Ridge, NY, Son of policeman, two brothers were policemen)

1945 NYPD Patrolman 76<sup>th</sup> precinct, Red Hook

1948-51 Patrol Sergeant with Emergency Services, NYPD

1951-54 Lieutenant NYPD 74th precinct, Brooklyn under Michael Murphy

1954 St. Johns BA

1954 lecturer in Police Science at Baruch, COPS

1954 assigned to work to establish a program at the Baruch School for higher education of police.

1954-61 Instructor, training officer, NY Police Academy

1957 FBI National Law Enforcement Academy graduate

1958 BA in business administration with specialization in Police Science

1960 MPA, CCNY (Baruch)

1961-63 organized and served as commander of police commissioner's inspection squad (against police corruption)

1962 Commendation for Bravery, NYPD

1963-64 Deputy Inspector NYPD

1963 Commander of Police Academy

(with Anna Kross, proposed a police college)

1963 Police Chief, Syracuse, NY (as a reformer, after corruption exposure there) (on leave of absence from NYPD for 18 months)

Reformer, appointed after scandal, established organized crime division and intelligence

1963 Governor Nelson Rockefeller's special Counsel on Law Enforcement

1964-65 commanding officer of police Academy (17 month job)

1964-65 Deputy Police Chief NYPD

1965 Retired from NYPD

1967-68 National Advisory Commission on Civil Disorders and Violence

1967-68 Public Safety Director, Washington D.C. (new position created for him)

1968 Washington D.C. riots, denied cops firearms to put down riots

(Appointed by President Johnston, left when Nixon elected)
