Description of the Collection:

The City of New York Commission to Investigate Allegations of Police Corruption and Anti-Corruption Procedures of the Police Department was informally known as The Mollen Commission after the commission chair, Judge Milton Mollen.

The Commission was appointed by David Dinkins, who was Mayor of New York at the time. This collection includes official typed verbatim transcripts of 4 days of public hearings (box 1). Some of which are available on the Lloyd Sealy Library's Digital Collections.

This collection also includes VHS tapes (boxes 2-3). These were informally taped without copyright permission from the NY1 television channel's broadcast of 7 days of the 1993 Mollen Commission hearings. The Library does not hold any rights to these recordings and cannot legally make copies of these tapes. These tapes are available for viewing in the Library by appointment.
